

BID SCHEDULE

Bidders Please Note: Before completing the Bid Schedule and Preparing the Proposal, carefully read "**Invitation to Bid**" and "**Notice to Bidders**", "**Instructions to Bidders**", "**Section 102 and Section 103**" of the Special Provisions of the Specifications.

The bidder shall state (in ink or type written) the bid price in words per unit measurement in the space provided in the Bid Schedule for every item for which a quantity is given.

The bidder shall also insert a unit bid price opposite each pay item name for which an estimated quantity appears in the Bid Schedule. A unit bid price is not to be entered nor tendered for any pay item for which no estimated quantity appears. Whenever a contingent amount is shown for any item in the **Bid Schedule**, such amount shall govern and be included in the bid total.

Basis of award of the bid shall be as described in Notice to Bidders, Instructions to Bidders, and Section 102 of the Special Provisions of the Specifications.
